**Public Notice**  
**New Visa on Arrival Eligible Country List**

The Government of Papua New Guinea recently announced the creation of a Visa on Arrival Eligible Country list.

This list is attached to this notice, and may also be viewed on our official website at <http://www.immigration.gov.pg/visa/visa-all/34-general-information-for-intending-visitors.html>

Effective immediately, travellers from these countries may obtain a single-entry tourist or single entry business visa on arrival.

In order to be eligible, travellers must hold a passport issued by one of these countries, which indicates they are a citizen of that country.

Holders of other documents issued by these countries, such as those issued to non-citizen residents, refugees, or overseas nationals are not eligible for visa on arrival.

Citizens of countries not listed need to obtain a visa from the nearest PNG mission abroad prior to their travel.

파푸아뉴기니 입국 시 통관 관련 정보를 아래와 같이 안내드리오니 방문 시 활용하시기 바랍니다.

## 1. 주재국 입국 시 다음의 세 단계 절차를 거침

### 가. 신고

- 작성한 물품신고서를 허위로 작성한 경우 관세법 위반으로 벌금이 부과되거나, 물품의 압류 및 행정상의 불이익을 당할 수 있음. 현지 세관에 제출하는 세관 및 검역 신고서의 경우 아래 사항들을 명확히 표기해야 함.
  - 무기류, 불온·외설 도서, 수렵·밀렵품, 불법의약품
  - 1천키나 이상에 해당되는 물품(18세 이하의 여행자의 경우 500키나)
  - 성인 1인 당 250개비 혹은 250g 이상의 담배 (18세 이상)
  - 성인 1인 당 2리터 이상의 주류 (18세 이상)
  - 상업적 용도의 물품 등

### 나. 녹색 or 붉은색 출구

- 도착 후 신고할 물품이 없다고 판단될 경우 녹색출구를 이용하고, 신고해야 할 물품이 있을 경우 붉은색 출구를 이용해야 함.

### 다. 수화물 검색

- 세관 직원은 입국자에게 구두로 질문하거나 수화물을 검색 할 수 있음. 모든 입국자의 짐을 전수검사 하는 것은 아니며, 허용한도를 초과한 과세품(dutiable goods)의 경우 정상가액을 지불해야 함.  
또한 검역관들은 입국자가 신고했거나 혹은 판별기로 파악한 동식물류를 검수할 수 있음. 만약 해당 물품이 세관·검역 당국 신고 물품에 해당되는지 확실하지 않다면 세관 직원에게 문의하시기 바람.

## 2. 파푸아뉴기니 반입 금지 품목

- 마약류
  - 마약류 반입은 투옥에까지 이를 수 있는 엄중한 처벌 품목이므로 절대 휴대 금지.

## ○ 총기 및 무기류

- 잭나이프, 단검, 지팡이 칼, 주먹 둔기류 등의 무기류 및 공기총, 가스총, 조명탄, 시합출발신호용 총 등의 총기류는 반입이 제한적이며, 반입 시 신고를 요함.  
동 물품은 경찰당국의 승인이 필요한 품목임.
- 보안상의 문제가 발생할 수 있으므로 해당 품목들은 기내 및 선내에서 소지해서는 안 되며, 기내 및 선박의 화물칸을 통해 운반해야 함.

## ○ 영상물

- 비디오테이프와 영화 등은 1989년에 제정된 검열법의 검열 대상이며, 통관에 일정 기간이 소요될 수 있음.

## ○ 외설물

- 사회통념 및 파푸아뉴기니정부에 반한다고 판단되는 풍기문란한 사진·영상물은 반입이 금지됨.

## ○ 의약품

- 습관성 약물 및 진통·마취성 약물을 복용해야 할 경우, (이노제, 억제제, 흥분제, 심장약, 진정제, 수면제 등)의 사로부터 받은 처방전을 소지해야 하며, 기존의 정해진 용기에 수납해야 함.

## ○ 검역

- 구두 혹은 서면으로 검역 신고 시, 다음 사항들이 명기되어야 함 : 최근 14일 내 농장, 도살장, 육류가공 및 포장업체 방문 여부 및 동물혹은 농산물과의 접촉 여부

## ○ 농산품 및 식품류 관련 금지 품목

- 모든 종류의 음식물류, 살아있는 것, 훈제, 캔류, 가공품등을 포함한 모든 식품류
- 식물류의 경우 살아있거나 건조된 구근, 꽃, 줄기, 모든 종류의 목재, 대나무, 씨리얼, 면류, 미역 등
- 육류의 경우 육류, 정액, 살라미, 소세지, 햄, 닭고기, 버터, 치즈, 깃털, 털, 가죽, 난류, 유아용 이유식 등
- 생물학 표본, 백신, 혈액류, 배양균류 등
- 동물이나 식물과 접촉 사실이 있는 모든 종류의 장비
- 스포츠 도구 : 골프채, 축구화, 럭비화 등

## ○ 애완동물

- 개나 고양이를 비롯한 모든 종류의 애완동물 반입은 엄격히 금지되어있음.
