



GUIDELINES FOR TRAVEL INTO AND OUT OF BRUNEI DARUSSALAM AIR – LAND – SEA

1. INTRODUCTION

- (a) This document outlines requirements for **inbound travel into and outbound travel from Brunei Darussalam** via **air, land and sea**.

2. LIFTING OF TRAVEL MEASURES

- (a) With high vaccination coverage and stable COVID-19 situation, **Brunei Darussalam has lifted all its travel measures to promote international travel recovery:**
- (i) Vaccination status, pre-departure and post-arrival COVID-19 test as well as quarantine **are not required**;
 - (ii) Travellers **are not required** to complete Arrival Declaration Form or obtain Entry Travel Pass approval and Exit Approval.
 - (iii) **Effective 1 December 2022**, travel medical insurance with COVID-19 coverage is **no longer mandatory** for:
 - o Short-term visitors (foreign nationals) who enter Brunei Darussalam;
 - o Brunei Citizens and Permanent Residents travelling abroad for short-term trip.



However, travellers are recommended to purchase a valid Travel Medical Insurance before travelling. This is intended to protect travellers from any medical or treatment costs that may be incurred following COVID-19 infection or any emergency/incident (depending on the insurance coverage). Travellers are also advised to check the entry requirements of destination country including provisions on vaccination and health insurance.

3. REVIEW OF TRAVEL REQUIREMENTS

- (a) Review and revision of travel requirements are subject to continuous risk assessment given the evolving COVID-19 situation.



ENTRY INTO BRUNEI DARUSSALAM

GENERAL TRAVEL ADVICE:

Travellers intending to enter Brunei Darussalam must comply with prevailing entry requirements to ensure a smooth journey.



PASSPORT

Ensure passport is in good condition and have at least 6 months validity period.



VISA

Check Visa requirements before entering Brunei Darussalam. Foreign nationals may refer to Ministry of Foreign Affairs (MFA) website for latest Visa requirements.

REQUIREMENTS OF DEPARTURE COUNTRY

Travellers must adhere to requirements of departure country. Travellers are advised to check prevailing requirements of departure country including vaccination requirement, pre-departure COVID-19 test and insurance requirement.

DEPARTURE FROM BRUNEI DARUSSALAM

GENERAL TRAVEL ADVICE:

Travellers must adhere to entry requirements and health protocols imposed by the countries they are travelling to and comply with entry requirements upon return to Brunei Darussalam.



PASSPORT

Ensure passport is in good condition and have at least 6 months validity period.



VISA

Travellers are advised to check Visa requirements of the countries they are travelling to before exiting Brunei Darussalam. Please check with travel agent, foreign embassies or refer to the website of destination country for latest Visa requirements.



REQUIREMENTS OF DESTINATION COUNTRY

Travellers must adhere to requirements of the destination country. Please check with the authorities of the destination country on any travel restrictions and entry requirements imposed on travellers departing from Brunei Darussalam.



E-REGISTER REGISTRATION

Brunei Citizens and Permanent residents are encouraged to register their travel itinerary on Ministry of Foreign Affairs (MFA) e-Register prior to their trip abroad. The information provided will allow MFA to get in touch with you in the event of emergency or crisis.

OTHER TRAVEL REQUIREMENTS

TRANSIT THROUGH BRUNEI DARUSSALAM



TRANSIT/TRANSFER THROUGH BRUNEI INTERNATIONAL AIRPORT

Passengers are permitted to **transit/transfer through Brunei International Airport**. Transit/Transfer passengers who intend to clear immigration upon arrival at Brunei International Airport and check-in again for their onward flight to the destination country, must ensure they fulfill prevailing entry and exit requirements.



TRANSIT VIA LAND & SEA

Transiting via land and sea from one control post (upon entry) to other control post (upon exit) is permitted provided that all prevailing entry/exit requirements are complied with.

EXIT & ENTRY CHARGES



CAJ PERKHIDMATAN (CaP)

Any person who intends to leave or enter Brunei Darussalam through land control posts (checkpoints) either via vehicle or as a pedestrian will be subjected to '**Caj Perkhidmatan**' - **CaP (charge rate of BND\$3.00 per person for a one-way trip)**. Application must be submitted to Royal and Customs Excise Department (RCED) via **Exit and Entry System (EES)**:

APPROVAL / PERMIT / ENDORSEMENT



Travellers/Transport Operators must obtain **necessary approval / permit / endorsement from relevant Government agencies**. Please check requirements and procedures that are enforced by respective Government agencies.
