# 'Green fees' for foreign passports

PAPUA New Guinea will now implement "green fees" of about US\$11 (K50) on all foreign passport holders entering and leaving the country starting next month.

This was announced yesterday by Environment Conservation and Climate Change Minister Simo Kilepa and the acting managing director of Climate Change Development Authority (CCDA) Debra Sungi in Port Moresby.

The CCDA is implementing the green fee initiative as part of its efforts to enhance climate finance and promote climate resilience and sustainable economic growth as part of its ongoing efforts in mobilising climate finance and contribute towards the country's climate resilience and sustainable economic growth.

Under the Climate Change (Management) (Amendment) Act 2023, green fees will be charged to all foreign passport holders entering and leaving the country, generating revenue to fund climate resilience, adaptation and mitigation programmes.

Sungi said that while this initiative came at a challenging time, it would play a critical role in financing climate mitigation activities and strengthening PNG's ability to respond to environmental threats.

To support its implementation, the National Airports Corporation (NAC) has committed an operating counter and CCDA is now finalising the standard operating procedure (SOP) and a 12-month lease agreement to roll out the collection of the green fees or the carbon offset fees.

Alongside green fees, CCDA is also advancing climate change statutory fees and levies, further expanding its capacity to generate tax and non-tax revenues.

This will involve the Treasury and Finance departments.

These mechanisms, including carbon levies, are expected to contribute up to K71.93 million annually by 2025, reinforcing PNG's financial stability in addressing climate challenge.
